- (ii) a reduction in the water tariff for senior citizens homes from twelve (12) cents per gallon to three (3) cents per gallon to a ceiling of 5,000 gallons. For use in excess of 5,000 gallons, the normal commercial rate will apply effective from 1 May 2019; and
- (iii) an increase in water tariff of 2.3 cents per gallon for all other users, effective 1 May 2019.
