- (ii) noted that further requests for additional monies from statutory bodies and GoA departments were placing added pressures on the recurrent and capital expenditures;
- (iii) continued to stress the repercussions for 2019 and beyond due to the prolonged sale of the GoA's shareholding in Anglec and the repercussions this would have for the release of the CDB policy based loan (PBL);
- (iv) agreed that prudent measures would have to be taken in order to meet GoA's commitments whether to look at relocation warrants, prioritisation/deferral of matters:
- (v) agreed that revenue figures be revised and to consider whether a supplementary budget in 2019 was needed; and
- (vi) agreed that work had to be accelerated on Anglec and the two (2) pieces of legislation (Physical Planning Act and Regulations and the Environmental Management Act) which were important to realising the PBL.
