The Fiscal Review Team made a presentation to Executive Council on the Fiscal outturn for the period up to 30 June 2019. The following points were noted,

- (a) recurrent revenue (EC\$ 126.70 million) was EC\$14.64 above the budget estimate of EC\$112.06 for the first half of the year;
- (b) recurrent expenditure (EC\$ 100.80 million) was EC\$2.4 million below the budget estimate of EC\$103.28 million for the first half of the year;
- (c) consequently the recurrent surplus for the first six months of the year stood at EC\$25.9 million, EC\$17.12 million above the budget forecast of EC\$8.78 million for the first six months of the year.

Council further agreed that:

- (i) in accordance with the Fiscal Responsibility Act the Medium Term Economic and Fiscal Plan would need to be amended for the period 2020 to 2023 recognizing the half year out turns for 2019 and the implications of the delayed ANGLEC sale, the delayed release of the CDB PBL and the GoA's decision not to implement the Bulk Fuel Import License Fee in 2019; and
- (ii) the Hon Premier would write to the CDB and the UKG informing them of the decision not to implement the Bulk Fuel Import License Fee in 2019.

Council thanked the team for their presentation.
