EX MEM 19/236 EXCHANGE OF LANDS BETWEEN ANGUILLA SOCIAL SECURITY INVESTMENT AND DEVELOPMENT COMPANY (ASSIDCO), ANGUILLA SOCIAL SECURITY BOARD AND THE CROWN – PROPERTY SITUATED IN REGISTRATION SECTION WEST CENTRAL, BLOCK 28409 B DESCRIBED AS PARCELS 54, 59 AND REGISTRATION SECTION ROAD, BLOCK 08412 B, DESCRIBED AS PARCELS 276 AND 172

Council:

- (i) thanked the officials for the work on the paper;
- (ii) agreed to the exchange of certain lands overall situated in Registration Section North Central, Block 48814 B, described as Parcels 272 (part of), 93 and 224 (part of) and in Registration Section South Central, Block 38611 B, described as Parcel 305, assessed at a value of US\$3,960,000.00/EC\$10,645,272.00;
- (iii) agreed that in the first instance the Crown should exchange lands situated in Registration Section North Central, Block 48814 B, described as Parcels 272 (part of) being 6.4 acres of land valued at US\$3,310,000.00/EC\$8,897,942.00
 - with Anguilla Social Security Board and Anguilla Social Security Investment and Development Company for lands situated in Registration Section Road, Block 08412 B described as Parcels 172 and 276 and in Registration Section West Central, Block 28409 B described as Parcels 54 and 59, having a total acreage of 3.63 acres of land and overall value of US\$2,083,022.88/ EC\$5,599,582.11;
- (iv) agreed that ASSIDCO and ASSB acknowledge that there is a difference in value in the amount of US\$1,226,977.12/EC\$3,298,359.89 and that said sum be paid to the government and secured by the MFEDICT for use against further compulsorily acquisition costs, subject to final compensation amounts;
- (v) agreed that consideration would be given to increase the Land Acquisition Act Head to reflect the amounts needed for compulsory acquisition when the figures are determined;
- (vi) agreed that the Attorney General Chambers draft a Heads of Terms Agreement on behalf of the Government of Anguilla to be entered into between ASSIDCO and ASSB and the Government of Anguilla regarding the exchanges and the additional sum of US\$1,226,977.12/EC\$3,298,359.89 to be paid by ASSIDCO and ASSB; and

(vii) agreed that the tenants on land situated on Parcel 272 (Part of) should be notified in writing that the property is to be transferred to ASSIDCO and ASSB and that they should contact said corporate entities to enter into new tenancy within three (3) months. The Attorney General's Chambers shall provide a letter for issuance.

Council noted that the associated cost represents interest, transfer fees, legal fees, valuation fees, rental fees and other fees by the ASSB and ASSIDCO and the Anguilla Air and Sea Ports Authority (AASPA). Council felt that legal fees should not be associated with the sellers' transaction and that sellers should assume that cost. Council asked for clarity on this.
