- (ii) noted that if Scenario 2 is the approved option it would be necessary to revisit the spending submissions to prioritise the recurrent expenditure within the approved envelope of EC\$224,567,298 a cut in submissions of EC\$20.7m;
- (iii) further noted that it would be very challenging to submit a budget to the House of Assembly before the end of the year given the considerable amount of work required to bring the estimates into some measure of balance;
- (iv) agreed that:
 - (a) there should be no new taxes in 2020 and no increase in the rates of existing taxes and fees;
 - (b) the 2020 Budget should not be submitted until January;
 - (c) Embarkation Tax and Airline Ticket Tax should not be repealed before the end of the year; and
 - (d) no consideration of the decision to AASPA be given before year-end.
