# **MATTERS ARISING FROM THE MINUTES**

#### EX MIN 20/307 UK FINANCIAL AID – UPDATE ON FINANCIAL AID MOU

Hon Parliamentary Secretary and Economic Development, Special Ministerial Assistant to the Hon Minister for Social Development/Education and Financial Specialist remained. PS, Finance Mrs. Kathleen Rogers and Accountant General Mr. Vonlee Harris joined.

#### Council:

- (i) noted the update from the Premier and Minister of Finance, specifically that the claim for April had been submitted. The Premier further indicated that progress on the claim for May and June is going well and will be submitted shortly;
- (ii) noted that by the exchange of letters the Premier and Baroness Sugg have agreed to the revised timelines for provisions, 3, 4, 7 and 9 of the MOU; and
- (iii) further noted the difficulty experienced in showing that concession agreements had been approved. This indicates the urgent need to improve the proper record keeping, audit trails and compliance checks with MOUs and other agreements.

# <u>2021 BUDGET – PREPARING THE BUDGET AND MEDIUM TERM</u> ECONOMIC AND FISCAL PLAN

Hon Parliamentary Secretary and Economic Development, Special Ministerial Assistant to the Hon Minister for Social Development/Education and Financial Specialist remained.

Council noted the brief of the Financial Specialist on preparing the budget and Medium Term Economic & Fiscal Plan (MTEFP), specifically that:

- (i) the Fiscal Responsibility Act requires the preparation of the MTEFP and the annual budget flows directly from the context set by the MTEFP;
- (ii) thus far the MTEFP has not been updated since 2018, consequently annual budgets have required UK Government approval.

Council agreed that it was essential to commence work on the MTEFP and the 2021 budget immediately in order to determine what financial aid is required upon exhaustion of the current financial aid in December 2020.

- (iii) agreed that the Hon. Deputy Governor would supervise work to be undertaken by the Permanent Secretaries to determine the revenue implications of Covid-19 and the contingent liabilities by 31 July; and
- (iv) agreed that the Hon. Deputy Governor would work with Honourable Ministers to begin the process of a more strategic review of the future for each of the statutory bodies.
