MATTERS ARISING FROM THE MINUTES

Council noted that:

- work is continuing on the report on reform of the Interim Stabilization Levy;
- 2) work is continuing on the appointment of the Supply Officer, the Attorney General's Chambers have provided advice and the PS, Finance will make a determination shortly;
- 3) the Statutory Bodies continue to submit their quarterly financial reports and this process is proceeding well. The quarterly financial reports of the Anguilla Development Board are outstanding. The Statutory Bodies should prepare their work plans and budgets for 2021 by the end of November and present them for consideration by Executive Council on December 3;
- 4) the portal for the applications of returning residents has been updated, so that the applications are processed separately from those of visitors and they will be managed by a dedicated team; and
- 5) work is in hand to ensure the arrival fees collected under the Quarantine Act are directly credited to the Consolidated Fund.
