EX MIN 20/184 **COVID-19 UPDATE**

Council noted that:

- (i) two test results for confirmation of recovery were pending;
- (ii) there was a sudden death of a 26 year old female in Anguilla, which occurred on the morning of Thursday 23 April 2020. Due to the urgent situation, samples were sent overseas to rule out COVID-19 in this investigation. A first test was to be done in Saint Maarten on Thursday 23 April and a further sample to be sent to the Caribbean Public Health Agency (CARPHA) on Friday 24 April for testing; and
- (iii) following the results of these tests to rule out COVID-19 in this investigation, and the confirmation of the two pending recovery results, consideration would be given in subsequent meetings of Executive Council on the de-escalation of the current restrictions on movements and mass gatherings in a phased approach over the coming weeks.
