**EX MEM 20/120 EXTENSION OF THE REPORTING DEADLINES FOR FATCA AND CRS RETURNS FOR THE REPORTING CALENDAR YEAR 2019**

Hon Parliamentary Secretary, Ministerial Assistant to the Hon Minister, MHA and Financial Specialist remained.

Council:

- (i) approved in principle the extension of the reporting deadline for FATCA until 15 December 2020, and the extension of the reporting deadline for CRS returns until 15 September 2020 for the reporting calendar year 2019; and
- (ii) instructed the Attorney General’s Chambers to commence drafting amendments to the International Tax Compliance (CRS) Regulations, 2016 and the Foreign Account Tax Compliance Act (United States of America) Regulations, 2017 to extend the reporting deadlines therein.

**EX MEM 20/121 CLAIM BY REGISTERED PROPRIETOR FOR ROAD ACQUISITION OF PROPERTY SITUATED IN REGISTRATION SECTION NORTH, BLOCK 58916 B, PARCEL 374 (PART OF)**

Hon Parliamentary Secretary, Ministerial Assistant to the Hon Minister, MHA, Financial Specialist and PS, Health, Lands & Physical Planning remained. Director, Lands & Surveys, Mr Leslie Hodge joined.

Council agreed that:

- (i) the registered proprietor of property described in Registration Section North, Block 58916 B, Parcels 374 (part of) be paid the amount of US\$157,000.00/ EC\$422,047.40 for the acquisition of 2.34 acres of land acquired by the Government of Anguilla for road development in 2004 as delineated on GIS Map conditional upon the transfers being executed by the personal representative of the estate;
- (ii) the payments would be made in accordance to the draft agreement between the relevant parties and the Government of Anguilla; and
- (iii) the Ministry of Infrastructure, Communications, Utilities and Housing (MICUH) and Department of Lands and Surveys prepare a schedule of affected lands at Tackling for this road improvement matter. Thereafter, the schedule be submitted to Executive Council for consideration and declaration as part of the public road under the Roads Act.
