EX MIN 20/43 EX MEM 20/28 BRIEFING AND RECOMMENDATION FOR THE CONTROL OF NOVEL CORONA VIRUS (2019-nCoV) IN ANGUILLA

Hon Parliamentary Secretary and Financial Specialist remained. The following persons joined:

Council noted apologies from the Chief Medical Officer, Dr Aisha Andrewin who is in Trinidad attending a conference concerning the Novel Corona Virus.

Following on from EX MIN 20/37 of 30 January, Council noted that the World Health Organisation (WHO) has updated the status of the Novel Corona Virus to the level of a public health emergency of international concern.

Council considered and agreed that:

- (i) based on the current information available from the WHO, any travel or trade should not be banned;
- screening of passengers at ports of entry to identify passengers who have travelled to China within the last fourteen days will be implemented.
 Passengers who have been identified as having visited China within a fourteen day period will be referred to the health services for quarantine for the recommended period of time or to the Princess Alexandra Hospital for treatment whichever is more appropriate;
- (iii) the Ministry of Health and the Health Authority of Anguilla should continue to implement its action plan for the prevention and control of the transmission of the virus in Anguilla, and the management and treatment of cases should they occur, and to work collaboratively with the Immigration Department for screening services;
- (iv) the Ministry of Health and the Health of Authority of Anguilla should ensure that there is adequate staffing of relevant services for the monitoring and treatment of quarantined passengers;
- a protocol team be established to deal with issues regarding detention of passengers, getting samples to the lab within appropriate time, how information is being disseminated, effective control and other logistics;
- (vi) hygiene signage would continue to be posted in entry area at all ports of entry. Hand sanitizers would be made available for passengers and staff;
- (vii) discussion with the Ministry of Health and the Attorney General's Chambers on having regulations in place pertaining to the appointment of a quarantine authority; and

(viii) a press release be made by the Minister of Health on the status of the virus and Anguilla's position.
