EX MIN 20/144 COVID-19 ANGUILLA RESPONSE UPDATE AND RECOMMENDATIONS

Further to EX MIN 20/143 of 24 March, Council agreed as follows:

(i) Restriction on public gatherings

Pursuant to section 8 (c) of the Public Health Act, for the purpose of preventing or controlling the spread of the Covid-19 disease, any public gatherings of 5 or more persons in any public place in Anguilla is prohibited with effect from Thursday 26 March 2020 to Thursday 9 April 2020.

(ii) Restriction on hours of operations

Bars restricted to operating hours between 7 am to 7 pm effective 11:59 pm from Thursday 26 March 2020 to Thursday 9 April 2020.

(iii) Prohibition of restaurant sit-down services

No restaurant shall offer sit-down services from Thursday 26 March 2020 to Thursday 9 April 2020. Restaurants would be permitted to offer take-out services during this period and should not allow the congregation of more than 5 persons at the restaurant at any particular time.

(iv) Offence

Any person who fails or neglects to carry out or infringes any provisions of these regulations is guilty of an offence and is liable upon summary conviction to a fine of \$2,500 or to imprisonment for a term of 6 months or to both.

Council additionally agreed that the Public Health (Temporary Restrictions on Public Gatherings) Regulations, 2020 should be signed by the Hon Minister for Health and published in the official gazette effective 26 March 2020.
