# ANGUILLA AIR AND SEAPORT AUTHORITY (SPECIAL PORT DUES) (ROAD BAY) REGULATIONS, 2016

Statutory Instruments of Anguilla No.: 20/2016

### RESOLUTION

**WHEREAS**, the primary goal of the Anguilla Air & Sea Ports Authority (AASPA) is to be a self -sustaining and financially viable body;

**AND WHEREAS**, the August festive period imposes a financial burden on AASPA as the need for services to boats and passengers and the cleaning and maintenance of various port facilities increases;

**AND WHEREAS**, the implementation of special port dues during this festive periods allows for an increase in revenue to assist in meeting the extra costs resulting from the August festive period;

**AND WHEREAS** section 86 of the Anguilla Air and Sea Ports Authority Act, R.S.A. C. A57 enables the Governor in Council to make regulations in relation to port dues;

**AND WHEREAS** the Governor in Council did make those regulations on 22<sup>nd</sup> July, 2016;

**AND WHEREAS** section 86 of the Anguilla Air and Sea Ports Authority Act, R.S.A. C. A57 provides that the regulations may not take effect until it is approved by a negative resolution of the House of Assembly;

**AND WHEREAS** those regulations are set out in the Schedule hereto;

**BE IT RESOLVED** that, under section 86 of the Anguilla Air and Sea Ports Authority Act, R.S.A. C. A57, the House of Assembly approves the regulations set out in the Schedule.

### ANGUILLA AIR AND SEA PORTS AUTHORITY ACT (R.S.A. C. A57)

# ANGUILLA AIR AND SEA PORTS AUTHORITY (SPECIAL PORT DUES) (ROAD BAY) REGULATIONS, 2016

Regulations made by the Governor in Council under section 86 of the Anguilla Air and Sea Ports Authority Act, R.S.A. c. A57.

### Interpretation

1. In these Regulations—

"authorised officer" means a person authorized by the Chief Executive Officer to collect special port dues;

"dollar" or "\$" means a dollar in the currency of the United States of America;

"passenger" means any person, other than a stowaway, being carried on a vessel, who is not a member of the crew of that vessel; and

"special port dues" means the port dues prescribed under section 2 of these Regulations.

### **Special Port Dues**

2. There shall be charged, paid and collected in respect of every vessel entering from a foreign port into the port of Road Bay, a special port dues, calculated at a rate of \$2 per passenger, and the special port dues shall be paid to the authorised officer by the captain of the vessel immediately upon their entering the port.

### **Exemptions**

3. The special port dues shall not be chargeable or payable in respect of Her Majesty's ships of war or those of any foreign government.

### Citation

**4.** These Regulations may be cited as the Anguilla Air and Sea Port (Special Port Dues) (Road Bay) Regulations, 2016.

### Commencement and expiration

5. These Regulations shall come into effect on the 30<sup>th</sup> day of July, 2016 and shall expire on the 13<sup>th</sup> day of August, 2016.
