1. AMMENDMENTS:

The following revisions have been made to the items listed below.

This Addendum forms part of the "Bid Documents" and modifies or clarifies the original "Bid Documents" for this Project dated 1st February 2016.

- The following clarifications are applicable to drawings and specifications for the project referenced above.
- Page 4 of the Bill of Quantities has been changed show the correct list of items to be priced and the amount of fencing needed.
- Page 29 of the Bill of Quantities has been changed to show the correct amount of reinforcement needed.
- Page 332 of the Bill of Quantities has been changed to show that Bill #18 has been added to account for the building staircases.
- Page 105 of the Specifications has been changed to show the addition of a section that deals with the sealing of the cistern walls and concrete roofs.
- Page 172 of the Specifications has been changed to show the provision of hot water.
- Page 174 of the Specifications has been changed to show the specifications for the shower and kitchen sinks and faucets, the provision of a solar water heater and hot water storage tanks.
- Section 16903 has been added to the Specifications for the security system specifications
- Section 15700 has been added to the Specifications for fire escape ladder specifications.

- Section 08800-2.2.3.1 of the Specifications specifies the type of lock that should be used for the project.
